Music programs: year-long instruction was provided in strings (voice violin, viola, cello, bass, piano, guitar, and harp), drums, and voice lessons, as well as instruction in electric guitar and electric bass. Due to COVID-19, lessons were conducted both in person (prior to March 13, 2020) and via Remote Video Conferencing (after March 14, 2020) and some of these virtual lessons continued into this year. We and piano instruction. The string program is the largest Suzuki program in Cincinnati with collaboration from The University of Cincinnati College Conservatory of Music - CCM Prep), taught three semesters of musical theater (one in person the other two remotely, and provided a year-long Musik Kids program for children 3 months old and up. The Suzuki program in violin, viola, cello, and piano included weekly lessons and group classes, and bi-monthly outreaches and recitals (group and solo). Suzuki students performed in six outreach programs. See Part III, Ln 4a statement

Art programs: In addition to group art classes, we offer one-on-one private art lessons - a rare find in the community. Open art studios provided year-long curriculum-based art classes, summer art camps, painting parties and holiday art celebrations. Year-long classes were offered in the following age groups: pre-k art, elementary art, middle school art, and high school portfolio. No School, Let's Art camps were offered during the school year for working parents. Partnerships with the Public Library of Cincinnati provided free artmaking experiences in underserved neighborhoods. We continue to grow our free library program to five libraries served: Elmwood Place, N. College Hill, Avondale, Northside and Reading. The following art disciplines were taught: drawing, painting, collage, clay, mixed art media, and other. Our team provided free art kits for pickup at area libraries so that we could continue our library programming during transitional periods. Summer camps were provided for students aged 3 - 15. Arts celebrations and See Part III, Ln 4b statement

Dance programs: hip-hop, and dancing with Parkinson's were held each week for the duration of the school year. Now in its sixth year, the Dancing with Parkinson's program offers free dance instruction and classes for persons afflicted with Parkinson's disease and their caregivers. This program is based on, and is a part of an internationally-acclaimed dance class program for people with Parkinson's disease called "Dance for PD@." in order to offer an effective class to the population affected by this disease, instructors are certified by the dance for pd@ program in New York (www.danceforparkinsons.org). Participants are empowered to explore movement and music in ways that are refreshing, enjoyable, stimulating and creative.

group piano classes, 4 weekly family music classes (ages babies - 3 yr), and

continued teaching private piano lessons for those children who began piano in  
the group class program. Two recitals were held at local retirement communities,

Other: Page 2 Part III Line 4b In response to the theft and burning of a neighbor's Pride flag from their home, we held classes and events that showcase the power of queer love through art. The Loving Wyoming project was launched on February 13, 2021. A call for artists and exhibitions were initiated and executed in person and digitally. This project served as a warm, welcoming celebration of the LGBTQIA+ community with Family Centered weekly art classes that began March 11, 2021. Classes included weekly projects that reflected on queer history. The program created an environment of diversity and inclusion and lead Wyoming and the surrounding neighborhoods in becoming a sanctuary and truly safe space for the queer community.

Other: Page 2 Part III 4d Our Faculty Jazz Trio provided a live stream concert for Facebook viewers. In partnership with the Wyoming Music Students Association, we participated in Porchfest, a national event, in the Wyoming Community. Outreach: The Center's neighboring Lockland Middle School students (grades 6th-9th) receive no art instruction during school-time. In the absence of free access to art education, the majority of these children would be left behind compared to those who can afford enrichment activities. The Center identified this partnership to provide instruction in music, art and spoken word. Through high-quality, free programming offered to these middle schoolers, by leveraging art, we can magnify community assets such as hope and resilience against community challenges. In response to remote learning, our team created the Cosse Learning Program that provided a safe space for children to do their remote learning. In order to stay within the mission, the program allowed for proctor time (remote learning), music classes, art classes, and energy - which consisted of yoga, outdoor activities, and dance - each day. This was developed as a direct result of the community seeking a
